COURSE DESCRIPTION:

This course approaches local sustainability issues from an interdisciplinary perspective. By looking at the ecological, social and economic aspects from a variety of discipline perspectives, a fuller understanding of sustainability is achieved. The broad range of perspectives is achieved through participation of guest speakers from other faculties and outside of the university as well as excursions outside of the classroom. Prerequisite: 60 credit hours

Certain threads that will be found throughout the course include the role of the arts in sustainability, aboriginal issues, social justice, human health, and landscape's relationship to identity.

As one small step towards living more sustainably, we ask that all students and guest speakers use only refillable beverage containers in class such as reusable coffee mugs and water bottles. Through education and small personal actions such as these, we can realize positive change.

COURSE OBJECTIVES:

- to introduce students to a broad range of sustainability perspectives with a focus on local issues
- to address themes from an ecological, social and economic perspective
- to explore the role of the arts and literary / cultural studies in sustainability
- to integrate learning about sustainability issues from different discipline perspectives into a fuller understanding of sustainability
- to enhance understanding of the interdisciplinary nature of sustainability issues
- to promote interdisciplinary thinking and balanced perspectives

FIELD TRIP:

A half-day field trip will be held on Friday, March 11th, 2016, 12:30-6:00pm. A waiver must be signed by each participant. Attendance is optional, but recommended. Confirmation of attendance is required by March 2nd, 2016.

EVALUATION: Students will be evaluated through a series of assignments as well as class attendance. The assignment requirements are posted on the course web site. A citation and standard referencing format is required whenever presenting a fact, idea, graphic or photo that is not your own. All assignments are graded individually and are individual efforts unless otherwise stated.
