In Memoriam: DR. MICHAEL HENDERSON (1935-2009)

Dr. Michael Henderson, born and educated in England, joined the University of Manitoba on January 1, 1968 as Assistant Professor in the Department of Food Science. Dr. Henderson taught Food Chemistry and Food Analysis as well as conducted research on food enzymes particularly lipases and lipoxygenase. Much of this work was done together with Dr. Michael Eskin with whom he wrote "Biochemistry of Foods" the first book geared to senior undergraduate and graduate students. The book was extremely well received and translated into Japanese, German and Malay. Fourteen months after the book was published over 2,000 copies had been sold in Canada, USA, Australia, Sweden and Chile. After 28 years of loyal and dedicated service, Dr. Henderson retired on October1, 1996 as a Full Professor. He was subsequently appointed a Senior Scholar from October, 1996 to September 30, 1998. Dr. Henderson and his wife, Anne, retired to Nanaimo, BC where he passed away on January 15, 2009.

Dear Dr. Barnard:

In accordance with the Student Discipline By-Law, I hereby submit the Annual Report of the University Discipline Committee (UDC) for the period September 1, 2007, to August 31, 2008. The attached Report on University Discipline cases summarizes all offenses and dispositions reported to me.

The Committee has continued to produce its report in chart format, and we have maintained the two major divisions, the first dealing with varying forms of "Academic Dishonesty" and the second addressing disciplinary matters which involve "Inappropriate Behaviour". Within each of the two major categories, like disciplinary matters have been grouped together for easier reference. Further, we have provided two graphs which offer a visual overview of disciplinary matters. The graphs span a five year period.

I would make the following observations concerning the report's contents:

- 1) I would note that this report only summarizes the disciplinary actions taken by the University of Manitoba. In the cases of more serious infractions, actions may have been also taken by outside authorities where appropriate.
- 2) There numbers for all areas remain relatively the same this year with the following exceptions:
 - a) There is a considerable drop in the number of reported cases of plagiarism.
 - b) The category "Unprofessional Conduct" continues to show a higher number as last year. The increase can be attributed this year primarily to students breaching the rules associated with membership passes. Perhaps, a new category should be established to cover such cases as they do not technically constitute professional misconduct.
 - c) The increase in the category "Disorderly/Threatening behvaiour" bears watching; however, the majority cases fall under disorderly behaviour and consideration should be given to creating two separate categories, providing a clearer picture.
 - d) Since 2004, the numbers under the Computer related incidents no longer include the spreading of computer viruses, hence lower

numbers in this category. There is a noted decrease in this category from last year. The numbers for last year were increased primarily due to copy right infringement which appears to have decreased by 50%.

As in past years, I would again request that this letter and the accompanying Annual Report be circulated to those individuals who have occasion to be concerned with disciplinary matters. As is evident in the report, the treatment and disposition of disciplinary matters across the University is certainly not uniform, as students in some faculties are dealt with much more stringently than other students for similar offenses. Further educational efforts to reach both students and those administering the penalties, would be helpful.

It has been your practice to provide a copy of the Report of the University Discipline Committee to members of Senate and the Board of Governors for their information. Should you choose to continue this practice, I would be prepared to attend the Senate meeting at the time this Report is presented and to speak to it, if called upon to do so.

The Board of Governors, at a meeting held on January 27, 2009, considered the following items of interest to Senate:

Reports of the Senate Committee on Awards

The Board of Governors approved the reports of the Senate Committee on Awards dated October 24, 2008 and November 24, 2008.

REPORT OF THE SENATE COMMITTEE ON AWARDS

Preamble

Terms of reference for the Senate Committee on Awards include the following responsibility:

On behalf of Senate, to approve and inform Senate of all new offers and amended offers of awards that meet the published guidelines presented to Senate on November 3, 1999, and as thereafter amended by Senate. Where, in the opinion of the Committee, acceptance is recommended for new offers and amended offers which do not meet the published guidelines or which otherwise appear to be discriminatory under the policy on the *Non-Acceptance of Discriminatory Scholarships, Bursaries or Fellowships*, such offers shall be submitted to Senate for approval. (Senate, April 5, 2000)

Observations

At its meeting of January 22, 2009, the Senate Committee on Awards approved seven new offers and the withdrawal of one offer, as set out in Appendix A of the *Report of the Senate Committee on Awards* (dated January 22, 2009).

Recommendations

On behalf of Senate, the Senate Committee on Awards recommends that the Board of Governors approve seven new offers and the withdrawal of one offer, as set out in Appendix A of the *Report of the Senate Committee on Awards* (dated January 22, 2009). These award decisions comply with the published guidelines of November 3, 1999, and are reported to Senate for information.

Appendix A

MEETING OF THE SENATE COMMITTEE ON AWARDS January 22, 2009

1. NEW OFFERS

J. David McLeod Scholarship

The many colleagues, friends and family of Dr. J. David McLeod have, through their generosity, added to his memorial bequest to establish an endowment fund at the University of Manitoba valued at \$20,000. The fund will be used to offer scholarships for students who want to internationalize their learning experience and become engaged global citizens. The available annual income from the fund will be used to offer one scholarship to an undergraduate student who:

- (1) has completed at least one year of full-time study (minimum 24 credit hours) at the University;
- (2) is enrolled full-time (minimum 60% course load) in the Faculty of Arts, in a program offered through the Department of Political Studies;
- (3) has achieved a minimum degree grade point average of 3.0;
- (4) will study abroad, for one or two terms, either on Letter of Permission or as part of a formal exchange programme between the University of Manitoba and a partner institution.

Preference will be given to students pursuing a concentration in international relations. Preference will be given to students who are participating in a formal University of Manitoba exchange program. The scholarship is not open to students who will complete University of Manitoba degree credit courses delivered abroad by a University of Manitoba instructor.

Candidates must submit: (a) an application letter; (b) a letter of intent outlining how the travel relates to their academic study and career goals; (c) two letters of support; (d) a detailed budget.

A student may hold only one J. David McLeod Scholarship in his or her lifetime.

The selection committee will be named by the Head of the Department of Political Studies.

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

Clayton H. Riddell Faculty of Earth, Environment, and Resources Graduate Entrance Scholarships

The Clayton H. Riddell Faculty of Earth, Environment, and Resources offers ten annual entrance scholarships, valued at \$5,000 each. The purpose of the award is to attract outstanding students to graduate programs offered by units in the Faculty. The scholarships will be offered to graduate students who:

- (1) are enrolled full-time in the Faculty of Graduate Studies, in the first year of a Masters or Doctoral program delivered by a unit in the Clayton H. Riddell Faculty of Environment, Earth, and Resources, including the Natural Resources Institute;
- (2) have achieved a minimum degree grade point average of 3.5 (or equivalent) based on the last 60 credit hours of study.

Entering students will be assessed based on their transcript(s) and application materials. The selection committee will also consider how to use the Scholarships effectively to attract outstanding graduate students.

Entrance scholarships will be allocated to each of the units comprising the Clayton H. Riddell Faculty of Environment, Earth, and Resources in proportion to the current enrolment of graduate students in the unit.

The award is tenable, at the same value, in the recipient's second year of study provided that he/she:

- (1) continues to be enrolled full-time in the Faculty of Graduate Studies, in a Masters or Doctoral program delivered by a unit in the Clayton H. Riddell Faculty of Environment, Earth, and Resources, including the Natural Resources Institute;
- (2) has achieved a minimum degree grade point average of 3.5 (or equivalent) based on the last 60 credit hours of study;
- (3) has received a satisfactory annual report from his/her advisor.

Recipients may hold the Clayton H. Riddell Faculty of Earth, Environment, and Resources Graduate Entrance Scholarships concurrently with any other awards, consistent with policies in the Faculty of Graduate Studies.

The Dean of the Faculty of Graduate Studies (or designate) will ask the Dean of the Clayton H. Riddell Faculty of Environment, Earth, and Resources (or designate) to name the selection committee for this award.

Clayton H. Riddell Faculty of Environment, Earth, and Resources Masters Thesis Prize

The Clayton H. Riddell Faculty of Environment, Earth, and Resources offers an annual prize valued at \$1,000 to the graduate student who:

- (1) has successfully completed all of the requirements for a Masters degree program delivered by any unit in the Clayton H. Riddell Faculty of Environment, Earth, and Resources, including the Natural Resources Institute;
- (2) has achieved a minimum degree grade point average of 3.5 (or equivalent) based on the last 60 credit hours of study;
- (3) has received approval of their thesis, and has submitted the final version to the Faculty of Graduate Studies between September 1 and August 31 of a given academic year;
- (4) from among those candidates who also meet criteria (1) through (3), has completed the best Masters thesis, as determined by the selection committee.

Nominations will be invited from faculty of the University of Manitoba. Nominations must be accompanied by two letters of support, one from the candidate's thesis advisor and one from a member of the candidate's examining committee. The letters should describe and explain the strengths, merits, and innovative nature of the thesis and the candidate's research.

The Dean of the Faculty of Graduate Studies (or designate) will ask the Dean of the Clayton H. Riddell Faculty of Environment, Earth, and Resources (or designate) to name the selection committee for this award.

Clayton H. Riddell Faculty of Environment, Earth, and Resources Ph.D. Thesis Prize

The Clayton H. Riddell Faculty of Environment, Earth, and Resources offers an annual prize valued at \$1,000 to the graduate student who:

- (1) has successfully completed all of the requirements for a Doctoral degree program delivered by any unit in the Clayton H. Riddell Faculty of Environment, Earth, and Resources, including the Natural Resources Institute;
- (2) has achieved a minimum degree grade point average of 3.5 (or equivalent) based on the last 60 credit hours of study;
- (3) has received approval of their thesis, and has submitted the final version to the Faculty of Graduate Studies between September 1 and August 31 of a given academic year;
- (4) from among those candidates who also meet criteria (1) through (3), has completed the best Doctoral thesis, as determined by the selection committee.

Nominations will be invited from faculty of the University of Manitoba. Nominations must be accompanied by two letters of support, one from the candidate's thesis advisor and one from a member of the candidate's examining committee. The letters should describe and explain the strengths, merits, and innovative nature of the thesis and the candidate's research.

The Dean of the Faculty of Graduate Studies (or designate) will ask the Dean of the Clayton H. Riddell Faculty of Environment, Earth, and Resources (or designate) to name the selection committee for this award.

Clayton H. Riddell Faculty of Environment, Earth, and Resources Undergraduate Admission Scholarships

The Clayton H. Riddell Faculty of Environment, Earth, and Resources offers five annual scholarships, valued at \$1,000 each, to undergraduate students who:

- (1) have completed a minimum of 24 credit hours in University 1;
- (2) in the next ensuing academic session, are enrolled full-time in his or her second year of study, in any baccalaureate degree program offered in the Clayton H. Riddell Faculty of Environment, Earth, and Resources;
- (3) are the five highest ranking students admitted to the Faculty in the year in which the award is tenable based on a minimum degree grade point average of 3.5.

In the event of a tie, the scholarship will be offered to the student who has completed the largest number of higher level courses in their first year of study.

The selection committee will be the Awards and Honours Committee of the Clayton H. Riddell Faculty of Environment, Earth, and Resources.

Clayton H. Riddell Faculty of Environment, Earth, and Resources Undergraduate Thesis Prize

The Clayton H. Riddell Faculty of Environment, Earth, and Resources offers an annual prize of \$1,000 to the undergraduate student who, in the regular session immediately preceding the deadline for nominations:

- (1) was enrolled full-time in the Clayton H. Riddell Faculty of Environment, Earth, and Resources, in any B.Sc.(Hons.) or B.A.(Hons.) degree program;
- (2) has achieved a minimum degree grade point average of 3.5;
- (3) from among those students who meet criteria (1) and (2) has submitted the best undergraduate thesis, as determined by the selection committee.

Nominations will be invited from faculty of the University of Manitoba. Nominations must be accompanied by a copy of the final version of the completed thesis and a letter of support from the candidate's thesis advisor.

The selection committee will be the Awards and Honours Committee of the Clayton H. Riddell Faculty of Environment, Earth, and Resources.

Dr. Jones and Katie Young Scholarship in Dentistry

Dr. Jones Young (D.M.D./87) and Mrs. Katie Young offer an annual scholarship to a student in the Faculty of Dentistry at the University of Manitoba. As a demonstration of the appreciation for the education that he received at the University of Manitoba, Dr. Young has established this scholarship to support the Faculty of Dentistry's Drive for Top 5 Campaign. One scholarship valued at \$1,000 will be offered to a student who:

- (1) has successfully completed the second year of study in Doctor of Dental Medicine (D.M.D.) program in the Faculty of Dentistry;
- (2) in the next ensuing academic session, is enrolled full-time in the third year of study in the D.M.D. program;
- (3) has achieved a minimum cumulative grade point average of 3.5;
- (4) has demonstrated a professional attitude in his or her interactions with instructors, staff, and fellow students and is a positive role model to fellow students.

The selection committee will be the Awards Committee of the Faculty of Dentistry.

2. WITHDRAWALS

Report of the Senate Committee on Instruction and Evaluation

Preamble:

- 1. The terms of reference for the Senate Committee on Instruction and Evaluation (SCIE) are found on the web at: <u>http://umanitoba.ca/admin/governance/governing_documents/governance/sen_committees/502.htm</u>
- 2. The Committee met on the above date to consider proposals from the Faculty of Human Ecology regarding the modification of graduation criteria and probationary standards for Interdisciplinary Health Degree Programs, from the Faculty of Agricultural and Food Sciences regarding criteria for *Dean's Honour Roll* and *With Distinction*, from the Faculty of Engineering regarding a *Start Afresh* option for students, and from the Faculty of Nursing regarding modification of the allowable time for completion of the Baccalaureate Program for Registered Nurses.
- 3. The Committee also discussed proposals for Unsuitability By-laws in the Faculty of Social Work and the Faculty of Education. Discussions are ongoing and will be reported to Senate in due course.
- 4. The Committee is also reviewing Senate recommendations of the SEEQ report, student access to final exams, deferred exam policies and procedures and software for detecting plagiarism.

Observations:

1. The Interdisciplinary Health Degree Program in the Faculty of Human Ecology offers programs in Health Sciences and Health Studies. The Faculty proposes that, effective for those students admitted beginning September 2009, the probationary standards be modified as noted below and that a DGPA of 2.5 be required for graduation.

2. The Faculty of Agricultural and Food Sciences proposes the modification of regulations regarding Dean's Honour Roll to assess students' eligibility at the end of each academic term. The proposed regulation would read:

Students who have completed a minimum of 12 credit hours of study in either the Fall or Winter terms and who have achieved a Term GPA of 3.5 or higher will be placed on the Dean's Honour Roll.

3. The Faculty of Agricultural and Food Sciences proposes to modify the eligibility criteria for students graduating '*With Distinction*'. Current regulations require that 90 credit hours be completed in the faculty; thus transfer students from the Agriculture Diploma program, those participating in 2+2 programs, and other transfer students, are not eligible for this honour. The proposed regulation would read:

The B.Sc. (Agriculture), B.Sc. (Agribusiness), B.Sc. (Agroecology) and the B.Sc. (Food Science) degrees with distinction will be awarded to students who have achieved a minimum degree GPA of 3.75 upon graduation.

4. The Faculty of Engineering is proposing to allow students who have been assessed as *ineligible to continue in an engineering program*, a *Starting Afresh* option. This will address issues of students who experienced academic difficulties which led to this assessment and who wish to return to engineering. This procedure will allow these students to be readmitted after a minimum two-year suspension period and to retain up to 40 credit hours of their successful coursework. The *Ineligible to Proceed in Engineering* section of the Calendar entry will reflect that the student may apply to *Start Afresh* after a period of two years.

Students who have become *Ineligible to Proceed in Engineering* may apply to the Dean for permission to start their degree afresh, should they wish to return to the Faculty of Engineering.

At the discretion of the Dean, a student may start afresh in an engineering program after a minimum period of two years from their last academic assessment by the Faculty of Engineering, and may request to transfer up to 40 credit hours in which a minimum grade of "C+" was achieved. All previous courses will remain on the student's academic transcript, but will not be applied to their new program.

5. The Faculty of Nursing proposes a reduction in the allowable time for completion of the Baccalaureate Program for Registered Nurses (BPRN) from seven to five years. It was noted that, when the program was established in 1987, students were required to complete 67 credit hours. Revisions in 2002 reduced the requirement to 45 credit hours. This proposal reflects the reduction in credit hours.

Recommendations

The Senate Committee on Instruction and Evaluation recommends:

THAT Senate approve that the academic standards for students in the Health Sciences and Health Studies degrees in the Interdisciplinary Health Degree Program, Faculty of Human Ecology, be revised such that effective for the admissions cycle beginning September 2009, students must attain a DGPA of 2.5 on graduation and meet the probationary standards as outlined in this report.

THAT Senate approve revisions to the Dean's Honour Roll regulations and the criteria for 'With Distinction' in the Faculty of Agricultural and Food Sciences as outlined in this report.

Report of the Senate Committee on Admissions concerning a proposal from the Faculty of Nursing to amend the entrance requirements for admission to the Bachelor of Nursing degree program under Option 2 (2009.01.21)

Preamble:

- 1. The terms of reference for this committee can be found at: http://umanitoba.ca/admin/governance/governing_documents/governance/sen_committees/490.htm
- 2. The Senate Committee on Admissions met on January 21, 2009 to consider a proposal from the Faculty of Nursing to amend admission requirements for the Bachelor of Nursing program. This proposal was approved at the October 28, 2008 meeting of the Nursing Faculty Council.

Observations:

1. Currently, there are two Options for admission to the four year baccalaureate program in the Faculty of Nursing, as outlined below.

Option 1 is available to students applying directly from University 1. To be admitted under Option 1, they must fulfill the following criteria:

- a. Complete 30 credit hours at a university level in the following identified courses (or their equivalent) with a minimum grade of "C" in each course
- b. Achieve a minimum adjusted GPA of 2.5. When space is available, students may be admitted with an AGPA of 2.0 2.49 (in descending order), based on the most recent 60 credit hours of university-level course work.

Note 2: English, Philosophy, History, Religion, Languages, Classics, Native Studies, etc. Humanities information is found in the Undergraduate Calendar in the chapter for the Faculty of Arts, Additional Faculty Regulations and Policies section; 5.1.1 "0900" level courses are not accepted. ARTS1110 (Introduction to University) is not a humanities course.

Note 3: Select from: Introduction to Psychology PSYC1200 (6), or Introduction to Sociology SOC1200 (6), or Human Origins and Antiquity ANTH1210 (3) and Cultural Anthropology ANTH1220 (3) **Note 4:** With the exception of Geological Sciences (GEOL 1XX0), courses under Clayton H. Riddell Faculty of Environment, Earth, and Resources do not meet the science elective requirement if taken in 2003-2004 and later. 1000 level introductory Geological Sciences courses (GEOL 1XX0) now offered under the Clayton H. Riddell Faculty of Environment, Earth, and Resources will be accepted as Science courses if taken prior to September 1, 2006.

Note 5: BIOL 1110 (Health and Health Professionals) may not be used as a Science elective. **Note 6:** Science Prerequisites – Students must meet the current Science prerequisites before registration for Science courses. See the *Undergraduate Calendar* for the current prerequisites. It is preferred that prerequisites have been completed within the last five years. Note that Math 40S is a prerequisite to Microbiology and Statistics.

Option 2 is available for students who have completed a degree, or at least 30 credit hours, and who then decide they wish to apply to the Faculty of Nursing. These applicants may have completed some or none of the Option 1 course requirements, but have the opportunity to be admitted to the Faculty and complete the first year requirements as a Nursing student. If the student has most of the Option 1 (first year) courses complete, he/she may be permitted to start year 2 courses concurrently with year 1. Please note, however, that this is a carryover from the previous transfer student category when students were admitted directly from high school. No changes were made at the time it was re-implemented for the program after the development of University 1.

To be admitted under Option 2 under the current admission policy, students must fulfill the following criteria:

- a. Complete 30 credit hours of university level course work with a minimum adjusted GPA of 2.5 based upon the most recent 60 hours.
- b. The courses taken should include 3.0 hours of 1000-level English and 3.0 hours of 1000-level science with a minimum of 'C' grade in each.

Students who do not have these subjects in their university course work must at least have completed the Senior high school equivalent in English (40S - 2 credits) and science (40S - 1 credit) with a minimum grade of 60% in each.

- 2. Nursing is a professional program, to which students are admitted based on universitylevel courses and grades. No other professional faculties who do not have direct entry have high school courses as an option for admission.
- 3. The following motion was passed by Faculty Council, Faculty of Nursing on October 28, 2008 and is now being forwarded to the Senate Committee on Admissions for approval and recommendation to Senate.

That the high school science and English requirements for Option 2 students applying to the Four Year bachelor of Nursing Program be dropped and that all students applying to the Faculty of Nursing under Option 2 be required to have one 1000 level English and one 1000 level Science, in addition to the other admission requirements for Option 2.

- 4. In addition to the rationale set out above, this change was recommended by the University of Manitoba's undergraduate Admissions Office to keep the Faculty of Nursing's admission requirements for students applying to the program under Option 2 consistent with those for University 1 students. Without this proposed change to the admission policy, there will be an increasing number of Option 2 students who will find that they do not have two high school English credits to substitute for the required 1000 level English credit when they are applying to Nursing. This change in admission policy will not affect students' success in the program.
- 5. Thus, the current high school science and English requirements for Option 2 students may no longer be used for admission purposes. The requirements under Option 2 would be as follows:
 - Complete at least 30 credit hours at a 1000 level or higher with a minimum adjusted grade point average of 2.5 based upon the most recent 60 credit hours. "0900" level courses (e.g., ENGL 0930) are not accepted for admission or transfer into Nursing.
 - Complete 3 credit hours of 1000-level English (thereby meeting the 'written English requirement') and 3 credit hours of 1000-level Science with a minimum grade of "C" in each course.

Recommendation:

The Senate Committee on Admissions recommends:

THAT Senate approve the proposal from the Faculty of Nursing to modify entrance requirements to the Bachelor of Nursing under Option 2 effective for admission to the term beginning September 2011.

Report of the Executive Committee of the Faculty of Graduate Studies on Course and Curriculum Changes

Preamble

- 1. The Faculty of Graduate Studies has responsibility for all matters relating to the submission of graduate course, curriculum and program changes. Recommendations for new programs or changes are submitted by the Faculty Council of Graduate Studies for the approval of Senate.
- 2. In October 2007, the Faculty of Graduate Studies approved a process of *Streamlining Course Introductions, Modifications, & Deletions* which allows the Executive Committee to approve these changes in lieu of Faculty Council when the courses are not associated with a new program or program changes.
- 3. The Faculty of Graduate Studies Executive Committee met on the above date to consider course changes with respect to the Masters of Physician Assistant Studies program (Medicine), Dept. of Biosystems Engineering (Agricultural and Food Sciences), and Dept. of Oral Biology (Dentistry).

Observations

- 1. The Masters of Physician Assistant Studies program proposes the deletion of three courses, PAEP.7040 Basic Medical Sciences for Physician Assistants (3), PAEP.7400 National Certification Examination (0), and PAEP.7200 Family Medicine for Physician Assistants (3) and the introduction of seven courses, PAEP.7042 Biochemistry for Physician Assistants (1), PAEP.7044 Statistics for Physician Assistants (1), PAEP.7046 Genetics for Physician Assistants (1), PAEP.7150 Year 1 Comprehensive Didactic Examination (0), PAEP.7300 PAEP Comprehensive Assessment of Clinical Skills (0), PAEP.7350 PAEP Final Project (0), and PAEP.7202 Clinical Family Medicine for Physician Assistants (6), to improve upon curricular inaccuracies that were included in the original program proposal.
- 2. The Dept. of Biosystems Engineering proposes the introduction of one course, BIOE.7180 Bioprocessing (3), to fill a gap in course offerings in Biosystems Engineering and the Faculty of Science. The course will be co-numbered with MBIO.7180 in the Dept. of Microbiology.
- 3. The Dept. of Oral Biology proposes the deletion of **ORLB.7030 Glandular Metabolism** and Secretion (3), and the introduction of **ORLB.7140 Cell Membrane and Cell Signalling (3)**, to update the Oral Biology graduate course listing in light of recent advances and up-to-date knowledge.

Comments of the Senate Executive Committee: The Senate Executive Committee endorses the report to Senate.

Recommendations

The Executive Committee recommends THAT: the course changes from the units listed below be approved by Senate:

PAEP 7046 Genetics for Physician Assistants (1) A brief introduction to medical genetics. Pre-requisite: Admission to PAEP Year 1.

PAEP.7150 Year 1 Comprehensive Didactic Examination (0) 0 A comprehensive, Program-administered examination covering material taught across all courses in Year 1 on the PAEP. Successful completion of this examination is required for the student to progress to Year 2 of the PAEP. Pre-requisite: Successful completion of PAEP Year 1 coursework.

PAEP.7300 PAEP Comprehensive Assessment of Clinical Skills (0) 0 The Comprehensive Assessment of Clinical Skills is a comprehensive summary of clinical performance using information from PAITRES, mini-CEX evaluations, and a Programadministered, didactic assessment of clinical knowledge. This course will be evaluated by using a pass/fail grading scheme. Pre-requisite: Completion of PAEP Year 2 clinical rotations.

PAEP.7350 PAEP Final Project (0)

A capstone project that may take a variety of formats as dictated by Program faculty. Students will, in consultation with a faculty member, develop and research a topic for presentation to

faculty and peers. This course will be evaluated by using a pass/fail grading scheme. Prerequisite: Successful completion of PAEP Year 1.

PAEP.7202 Clinical Family Medicine for Physician Assistants (6) +6 A clinical rotation designed to impart a practical understanding of Family Medicine, to prepare the physician assistant, within his or her scope of practice, to diagnose and manage conditions and issues related to primary care medicine and general practice. Pre-requisite: Successful completion of PAEP Year 1.
