## Report of the Executive Committee of the Faculty of Graduate Studies on Course and Curriculum Changes

## Preamble

1. The Faculty of Graduate Studies has responsibility for all matters relating to the submission of graduate course, curriculum and program changes. Recommendations for new programs or changes are submitted by the Faculty Council of Graduate Studies for the approval of Senate.
2. In October 2007, the Faculty of Graduate Studies approved a process of Streamlining Course Introductions, Modifications, \& Deletions which allows the Executive Committee to approve these changes in lieu of Faculty Council when the courses are not associated with a new program or program changes.
3. The Faculty of Graduate Studies Executive Committee met on the above date to consider proposals from the Dept. of Civil Engineering (Faculty of Engineering).

## Observations

1. The Dept. of Civil Engineering proposes the introduction of one (1) course to reflect the research expertise of a new faculty member in the department and a topic area that compliments the current suite of graduate courses on structural concrete. Due to the importance of concrete infrastructure to Manitoba and Canada, the course also responds to the need for educating engineers in this vital field.

## Course Introductions

## CIVL 7778 Durability of Concrete

Durability of concrete as a material. Deterioration of concrete in the field due to various damage mechanisms. Frost damage, corrosion of reinforcement, sulfate attack, etc. Durability-based design requirement in building codes.

## Report of the Executive Committee of the Faculty of Graduate Studies on Course and Curriculum Changes

## Preamble

1. The Faculty of Graduate Studies has responsibility for all matters relating to the submission of graduate course, curriculum and program changes. Recommendations for new programs or changes are submitted by the Faculty Council of Graduate Studies for the approval of Senate.
2. In October 2007, the Faculty of Graduate Studies approved a process of Streamlining Course Introductions, Modifications, \& Deletions which allows the Executive Committee to approve these changes in lieu of Faculty Council when the courses are not associated with a new program or program changes.
3. The Faculty of Graduate Studies Executive Committee met on the above date to consider proposals from the College of Medicine, Dept. of Landscape Architecture, and Asper School of Business.

## Observations

1. The College of Medicine proposes the introduction of two (2) courses, IMED 7120 Medical Biochemistry (3) and IMED 7170 Medical Genetics (3), offered by the Dept. of Biochemistry \& Medical Genetics, to provide students with a fundamental basis for teaching Medical Biochemistry and Medical/Human Genetics in the context of the human body, and to provide them with a better understanding of the context of biochemistry that many of the more specific graduate thesis projects are built upon. Students have identified a deficit in this area.

Course Introductions

IMED 7120 Medical Biochemistry
Biochemistry of carbohydrates, lipids, proteins and nucleic acids focused on those areas relevant to structure and function of the human body and disease processes. All students are expected to have completed an introductory biochemistry course. The course will consist of lectures, tutorials, and assigned studies.

IMED 7170 Medical Genetics
Designed to introduce graduate students to the field of human genetics. Both basic science and clinical issues will be discussed in this course.
2. The Dept. of Landscape Architecture proposes the deletion of (1) course, LARC 7300 Landscape Topics (3), and the introduction of (1) course, LARC 7400 Landscape Topics (3), to change the grading of the course from letter grades to pass/fail.

LARC 7300 Landscape Topics

## Course Introduction

LARC 7400 Landscape Topics 3
A critical examination of an individual topical study of relevance to contemporary landscape architecture. This course will lead to the completion of a practicum of thesis proposal. Course graded pass/fail.
3. The Asper School of Business requests that Ph.D. Management courses PHDM 7120 and PHDM 7130 (deleted at Senate in December 2013 and replaced with PHDM 7140 and PHDM 7150) be retained for one more academic year through to the end of summer term 2015. This permits Ph.D. students who have started these research paper courses and are continuing in them to complete them in the coming year. Any student starting these courses will be registered in the new course numbers staring fall 2014.

Dear Colleagues:
The Senate Committee on Medical Qualifications met on June 11, 2014 to consider the application from the Department of Pediatrics and Child Health, Faculty of Health Sciences, University of Manitoba to grant Dr. Gerhold a certificate under the academic seal of the university. Dr. Gerhold's curriculum vitae is enclosed. She is a Pediatric Rheumatologist with additional expertise in Immunology and management of chronic pain in children. The Department of Pediatrics and Child Health has had a single Pediatric Rheumatologist for over twenty-five years and there has been a prolonged search, nationally and internationally, to recruit two Pediatric Rheumatologists, as a sustainable replacement for the senior physician who has now retired.

Dr. Gerhold presently holds an academic appointment as a lecturer in the Department of Pediatric Respiratory Medicine and Immunology at the Charité - Universitätsmedizin Berlin, Germany. Due to her relatively junior academic appointment she is not eligible for academic certification from the Royal College of Physicians and Surgeons of Canada.

The Senate Committee on Medical Qualifications unanimously supports this application for use of Section 64. Dr. Gerhold is being considered for an academic rank of Assistant Professor. Dr. Cheryl Greenberg, Head of the Department of Pediatrics and Child Health considers, and the Senate Committee on Medical Qualifications agrees, that Dr. Gerhold will be an excellent academic clinician, based on the evidence of her scholarship in the first five years of her academic career. The referee letters and feedback from faculty following her recruitment visit have been uniformly positive.

In summary, the Senate Committee on Medical Qualifications would appreciate your support for this application of Section 64 of the Manitoba Medical Act to grant Dr. Gerhold a certificate under the academic seal of the University to the College of Physicians and Surgeons of Manitoba.

Subject: Regulations HNS programmes post July 12014
On May 20, 2014, the Board of Governors, on recommendation of Senate, approved the joining of the Department of Human Nutritional Sciences (HNS) to the Faculty of Agricultural and Food Sciences (FAFS). Accordingly, effective the Fall 2014 academic term, all associated programs in Human Nutritional Sciences will become part of the Faculty of Agricultural and Food Sciences. The proposal submitted to Senate noted the need for flexibility in the implementation of this move of HNS between Faculties during and immediately after the transition period. In subsequent discussions between both Faculties, HNS, and the Provost's office, it was agreed that such flexibility would be needed in particular for the regulations governing the undergraduate academic programmes offered by HNS as they move from the Faculty of Human Ecology (FHE) to FAFS. The programmes affected include:

- Bachelor of Science (Human Nutritional Sciences): includes Foods Option, Food Industry Option and Nutrition Option.
- Second Degree Option in Human Nutritional Sciences
- Human Nutritional Sciences / Red River College Culinary Arts Program
- Minor in Human Nutrition and Metabolism

It was agreed that, until such time as a full review of the academic regulations for these programmes has been carried out, the programmes should continue to be governed by the relevant FHE and HNS regulations. It was envisioned that the full review and Senate ratification must be completed before $30^{\text {th }}$ June 2015 .

At this point, as there is no possibility of gaining full approval for this transitional arrangement before $1^{\text {st }}$ July 2014, it is proposed that the resolution below be sent to FAFS Council for approval as soon as is feasible and then be passed on to the appropriate committees of Senate in order to gain full Senate approval as and when the Senate calendar allows. In the meantime we seek the agreement of the Provost's office that we can proceed as if this resolution had been fully approved.

The resolution to be presented to FAFS Council for approval is:
"Faculty Council approves the mòtion that after $1^{\text {st }}$ July 2014, programmes offered by HNS [list] continue to be governed by the relevant components of current FHE and HNS regulations until such time as a complete review of the regulations has been undertaken and the results of such review are approved by Senate."

At an appropriate point, which we suggest would follow formal approval of the resolution above by FAFS Council, the following statement be inserted into the university calendar under the appropriate headings for both FAFS and FHE. That statement will read:
"On May 20, 2014, the Board of Governors, on recommendation of Senate, approved the joining of the Department of Human Nutritional Sciences to the Faculty of Agricultural and Food Sciences. Accordingly, effective the Fall 2014 academic term, all associated programs in Human Nutritional Sciences will become part of the Faculty of Agricultural and Food Sciences. As outlined in the proposal submitted to Senate in May 2014, the implementation process will need to be flexible to best facilitate the appropriate approvals of any identified adjustments or changes, where required. In the interim and until such time that a review is completed and the required approval(s) received, the Human Nutritional Sciences programs - as listed below - will continue to be governed by the Faculty of Human Ecology academic regulations and the Human Nutritional Sciences program regulations."

As a consequence of this transitional arrangement, HNS faculty who presently serve on the FHE committees that are concerned with student standing and academic progression will continue to do so after July 1, 2014 at the invitation of the Dean of FHE. This will be of particular importance for confirmation of the graduands list for October 2014 Convocation.

## 1. NEW OFFERS

## Aramark Canada Ltd. - Daryl Lucyk Memorial Athletic Scholarship

Aramark Canada Ltd. has established an annually funded scholarship in recognition of their former District Manager, Manitoba Higher Education (Food Services), Mr. Daryl Lucyk. Mr. Lucyk was a keen supporter of Bison Sports and the Bison Football program, and he was considered a dear friend of the program upon his passing in December 2012. The purpose of the scholarship is to support current players of the Bison Football team. The Manitoba Scholarship and Bursary Initiative has made a contribution to this fund. In years where matching contributions are made through the Manitoba Scholarship and Bursary Initiative, two scholarships of $\$ 1,500$ each will be offered to undergraduate students who meet the selection criteria.

Beginning in the 2014-2015 academic year, one or more scholarships valued at \$1,500 each will be offered to undergraduate students who:
(1) are eligible to compete in Canadian Interuniversity Sport (CIS) and are members of the Bison Football team;
(2) are enrolled in a minimum 9 credit hours in their term of competition in any faculty or school at the University of Manitoba;
(3) have completed at least 18 credit hours in the previous academic session at the University of Manitoba;
(4) have achieved a minimum sessional grade point average of 2.0 in the previous academic session.

The Chair of the selection committee will be the Athletic Director (or designate) from the Faculty of Kinesiology and Recreation Management and will include the Head Coach of the Bison Football team (or designate).
The terms of this award will be reviewed annually against the Canadian Interuniversity Sport (CIS) criteria governing "University Academic Scholarships with an Athletic Component", currently numbered C. 5 in the CIS Operations Manual).

## Jaroslaw and Mary Barwinsky Scholarship

Dr. Jaroslaw Barwinsky has established an endowment fund at the University of Manitoba with an initial gift of $\$ 10,000$ in 2014. The purpose of the fund is to support students in their first year of studies in the Undergraduate Medical Education Program at the University of Manitoba. Christina and Ihor Barwinsky have made an additional contribution of $\$ 450$ to offer the first award in the 2014-2015 academic year. Beginning in the 2015-2016 academic year, the available annual income from the fund will be used to offer one scholarship to an undergraduate student who:
(1) is enrolled full-time in the first year of the Undergraduate Medical Education Program in the College of Medicine at the University of Manitoba;
(2) has ranked high on the Admission Composite score.

The Dean of the College of Medicine (or designate) will name the selection committee for this award.
The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

## Jennifer Brown Gerus Memorial Bursary

As a memorial tribute to Jennifer Rae Brown Gerus (PB Dip.Ed./07), Roman Gerus (B.Sc.(C.E.)/01) and daughter Natasia, along with Dr. Oleh Gerus (B.A/62, M.A./64) and Yvonne (Bonnie) Gerus (B.A./64) have established an endowment fund at the University of Manitoba. An initial gift of $\$ 30,000$ was made to establish the fund in 2013. The Manitoba Scholarship and Bursary Initiative has made a contribution to the fund. The purpose of the gift is to provide financial support to students in the Post Baccalaureate Diploma in Education program. Beginning in the 2015-2016 academic year, the available annual interest from the fund will be used to offer one or more bursaries to students who:
(1) are enrolled as full-time or part-time students in the Post Baccalaureate Diploma in Education program at the University of Manitoba;
(2) have achieved a minimum degree grade point average of 2.5 ;
(3) have demonstrated financial need on the standard University of Manitoba bursary application form;
Preference will be given to those students taking courses in the following areas of study: Counselling, Early Years Education, or Reading/Language Arts.
The selection committee will have the discretion to determine the number and value of bursaries offered every year.
The selection committee will be named by the Dean of Education (or designate).
The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

(1) are enrolled full-time (minimum $80 \%$ course load) in the second year of study in Bachelor of Education degree program in the Faculty of Education at the University of Manitoba;
(2) have achieved a minimum degree grade point average of 3.5.
- The second last paragraph has been removed.
- The selection committee has been revised and now reads: "The selection committee will be named by the Dean of the Faculty of Education (or designate)."

3. The Committee is to report to Senate on the determination of all appeals submitted to it; and advise the Executive Committee of any Senate regulations affecting students which appear to be creating particular difficulties.

## Observations:

1. The Committee has received 10 appeals since the last report to Senate in January 2014. These cases are summarized without compromising the confidentiality of the Appellant.

- An appeal was received against a decision by the Faculty of Graduate Studies. The grounds were failure of the Faculty/School or Dean/Director to follow procedures, failure of the Faculty/School or Dean/Director to follow the rules of natural justice, and failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed. The appeal was granted.
- An appeal was received against a decision by the Faculty of Graduate Studies. The grounds were failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed. The Committee determined there were no grounds to proceed to a hearing.
- An appeal was received against a decision by the Faculty of Science. The grounds were failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed. The Committee determined there were no grounds to proceed to a hearing.
- An appeal was received against a decision by the Faculty of Engineering. The grounds were failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed. The appeal was denied.
- An appeal was received against a decision by the Faculty of Graduate Studies. The grounds were failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed. The appeal was denied.
- An appeal was received against a decision by the Faculty of Nursing. The grounds were failure of the Faculty/School or Dean/Director to follow procedures, failure of the Faculty/School or Dean/Director to follow the rules of natural justice, failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed, that a Faculty/School/Senate governing document has become inapplicable through lapse of time or was unfairly applied, that there is an apparent conflict between a Senate governing document and a Faculty/ School governing document, and failure of Senate, the Faculty/School, or Dean/Director to comply with applicable legislation. The Committee determined there were no grounds to proceed to a hearing.
- An appeal was received against a decision by the Faculty of Arts. The grounds were failure of the Faculty/School or Dean/Director to follow procequres, failure of the Faculty/School or Dean/Director to
follow the rules of natural justice, and failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed. It was determined that the appeal was outside the jurisdiction of the committee, as all lower levels of appeal had not been exhausted.
- An appeal was received against a decision by the Faculty of Graduate Studies. The grounds were failure of the Faculty/School or Dean/Director to follow procedures, and failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being applied. The Committee determined there were no grounds to proceed to a hearing.
- An appeal was received against a decision by Extended Education. The grounds were failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed. The Committee determined that the appeal should be returned to Extended Education to consider new information.
- An appeal was received against a decision by the I.H. Asper School of Business. The grounds were failure of the Faculty/School or Dean/Director to reasonably consider all factors relevant to the decision being appealed. The Committee determined that the appeal should go to a hearing, but was settled prior to the hearing.

## 2. AMENDMENTS

## Furthering the Environment of Learning (FUEL)

The following amendments have been made to the terms of reference for the Furthering the Environment of Learning (FUEL):

- The preamble has been revised to reflect the following changes:
- The donor has renewed this award for an additional three years from 2013/2014 to 2015/2016.
- They have reduced the amount of the renewal gift to $\$ 45,000$ from $\$ 60,000$ and reduced the number of awards offered each year of the term from four to three.
- The value of each award has increased from $\$ 3,750$ each to $\$ 5,000$ each.
- The donor will no longer provide an award to students in the Department of Computer Science.
- The award is now only for Aboriginal students defined as Status, Non-Status, Métis, or Inuit. This is outlined in a new criterion (1).
- The former criterion (1) is now criterion (2). The words "(minimum 80\% course load)" have been added after "full-time". The word "penultimate" has been replaced with the words "second last".
- The former criterion (2) is now criterion (3). The degree grade point average has been reduced from 3.4 to 3.0.
- The former criterion (3) is now criterion (4).
- The former criterion (4) has been deleted.
- The selection committee paragraph has been revised and now reads:

The selection committee of: (a) I.H. Asper School of Business shall be named by the Director of Aboriginal Business Education Partners (or designate); (b) the Faculty of Engineering shall be the faculty's Scholarships, Bursaries, and Awards Committee; (c) the Department of Geological Sciences shall be the department's Awards Committee.
