### **Travel Risk Assessment and Emergency Plan**

Assessing your risks is an important aspect of responsible travel planning. Use this resource to assess and mitigate your risks. The administrators of this course will **not** store a copy, and it will **not** be uploaded to the UM Learn platform. However, your travel program coordinator or supervisor may request a copy.

First, think broadly about the following:

**Goals** – What are your goals and objectives for your travel?

**Expectations** - What are your expectations regarding living conditions, accommodation, food, climate, study/work placement, health regulations, cultural interactions, workplace safety, and communications?

Hosting Organization – What do you know about your host organization/institution/agency?

**Workplace/Classroom** - What will you be expected to do on this program? What are working/studying conditions like? Does the organization take steps to ensure a safe working/studying environment?

**Host Culture** - What is the political system in the country? How will your financial position, race, and social status compare with dominant culture or the majority living in your destination(s)? What things are taboo?

Accommodation – Have you found suitable accommodation? Will you have electricity, water, heat, etc.? What are the living conditions?

#### **Travel Risks**

A risk is a potential incident, activity or situation where your health and safety could be threatened. While abroad you will be in unfamiliar surroundings and will be exposed to different risks than usual. For example:

- Health Risks (epidemics, pollution, water and air contaminants, dietary concerns)
- Environmental / Natural Disasters (road conditions, floods, earthquakes)
- Civil Unrest (strikes, political turmoil, terrorism, violence, demonstrations, riots)
- Legal Risks (crime, petty theft, drug use)
- Serious Illness or Injury, including sexual assault and mental illness
- Other Traumatic Events (personal risks and emergencies)
- Linguistic, Cultural or Ethics-related risks

## Risk Self-Assessment, Analysis and Management

Use the chart below to assess any health, environmental, civil, legal or any other risks you may encounter.

- 1) Risk Identification List the predominant risks that you will encounter.
- 2) **Risk analysis** Describe possible negative effects of hazards, put risks into their contexts, analyze the exposure to the risk and identify your perceptions of the risk.
- 3) Risk Management Identify actions and precautions you can take to prevent or decrease impacts.

Risk Identification	Risk analysis	Risk Management
Example: Global Affairs Canada has identified the presence of Zika virus.	I could get sick, and perhaps have to return home. This increases risks if I (or my partner) get pregnant.	I will visit the Travel Health Clinic to get relevant information. I will avoid areas with a greater risk of infection.
Example: Earthquakes are fairly common at my destination.  Example: Laws are strict about drug usage, even for cannabis.	My safety could be threatened. Earthquakes are difficult to predict and can cause mass destruction.  I could be jailed, fined or deported. Foreigners are targeted by police for random searches.	I will ensure that I understand local earthquake procedures and what supports are available to me.  I will not use illegal drugs, and I will avoid situations where drugs are used.
