COURSE DESCRIPTION:

This course narrates and analyzes the history of the Vietnam War from the perspective of both Vietnamese and Americans. It begins by outlining the history of Vietnam including French colonial involvement. It focuses on the American stage of the war (1965-75) with its repercussions on the rest of the world.

The course is based on a series of bi-weekly lectures interspersed by a film history of the war produced by PBS. The film series should provide the basis for class discussion both of the war and the way it was represented in the media.

TERM WORK, SCHEDULE, TESTS, AND EVALUATION:

Class work will be worth 60% of the final grade.

The first assignment is an **in-class essay** on the question:

"The French claimed that they were civilizing Vietnam. Did they actually do so?" It will be written in the class of **September 12** following the showing (*on September 10*) of the Youtube film version of episode 1 of *Vietnam: A Television History*. https://youtu.be/zeVbQzDSBS0?list=PL4w-2j6Q0Qj5bQLu6gCb 1zVpd2IYgftR It is worth (5%).

There will be a one hour examination **October 12** based on two of three essay questions **(15%)** and an essay **(40%)** due on the last day of class, **December 7**, 2018. No late essays will be accepted.

The essay will consist of a 3000 word comparative review of the textbooks and the film series based on the premise "the Vietnam war was a mistake". In each case briefly relate the character of the narrative, its perspective, arguments, emphasis, biases, strengths and omissions as they relate to the premise that the war was a mistake. To what degree does a first person narrative better capture the war than a scholarly account? To what extent do nationality, gender and class affect perspective? What is left unsaid and why?

Keep copies of all work.

In addition to handing in a hard-copy of all written assignments, students are required to submit a copy of the paper electronically through UM Learn (as a word document). The file name for the

<u>FINAL EXAMINATION</u>: Based on the full semester's work. You will be required to answer **three** of five essay questions. (40%)
