The 2014 committee particularly encourages proposals for papers, sessions, and round-tables that examine, challenge, and refine the history of disease, health and the state. Suggested themes include local and global understandings of health, medicine, and governance; the consolidation, breakdown, or absence of state power in the midst of health and medical crises; and the experience of health and medical bureaucracies in the past.
