Overall, this course is intended to provide students with an opportunity to apply the theoretical knowledge they have acquired in this and previous criminology courses, and to gain experience in the conduct of criminal justice research in a ‘real life’ setting. In addition to attending lectures and tutorials dealing with research methods and tools, students will be placed within a justice-related agency to complete a research project relevant to the agency’s mandate.

Research findings often must be filtered through a network of political interests, fiscal realities, and various organizational needs and priorities. Therefore, it is important for students to develop an understanding of the context in which criminological research is interpreted and applied. Through this course, students will gain an understanding of the policy implications that are attached to both criminological theory and to the results of criminal justice research. The field placement will also expose students to the ways in which criminal justice and related agencies define needs and priorities, design and implement strategies, and deliver programs and services. Students will be supported in their projects through lectures, practical exercises, and tutorials in the use of statistical and/or presentation software.

Evaluation:

Grades will be determined on the basis of 4 assignments/exercises, and on the evaluation of various aspects of the field projects. Each of these components is described in more detail below.

- **Assignments and exercises (20%)**

Students will complete four written assignments/exercises over the course of the academic year. These are intended to reinforce the material discussed in the lectures, and to provide students with an opportunity to apply their statistical and presentation software skills. Each assignment is worth 5% of the final grade.

- **Literature review (20%)**
The literature review is one of the essential steps in conducting a research project; it summarizes prior research in a given area, and provides a context and rationale for new research. Through the literature review, students will demonstrate their familiarity with the existing knowledge and data that are relevant to their projects. Students must submit a typed, unbound hard-copy version, as well as an electronic version (e-mail/CD/diskette are all acceptable) in Microsoft Word format.

- **Research report (35% + 5%)**
The research report presents a detailed summary of the process and outcomes of the student's project. The report will contain an introductory/background section, a detailed description of the methodology employed, presentation of findings, and a presentation of the conclusions and recommendations that are supported by the research findings. Students must submit a typed, unbound hard-copy version (35%), as well as an electronic version (e-mail/CD/diskette are all acceptable) in Microsoft Word format. Following grading, students must submit a revised version (5%) for binding and presentation to the agency supervisor.

- **Power Point presentation (10%)**
PowerPoint presentation software is commonly used to present the results of research to clients and other audiences. Students will prepare and deliver a presentation (at a time to be arranged by the student and their supervisor) to the agency in which they conducted their research. For grading purposes, students must submit a hard-copy version, as well as an electronic version.

- **Poster board presentation (5%)**
Poster boards are a means to present research findings in a graphical fashion, allowing viewers to quickly grasp the purpose, process, and findings of a project. Students will prepare a poster board for presentation at the year-end exposition for academics and criminal justice personnel.

- **Agency evaluation (5%)**
Each student's performance during the placement will be evaluated by relevant agency personnel.

Note: With the exception of the assignments/exercises, all of the required course work listed above must be completed in order to pass the course.
