**Objectives of the course:**

This course provides an introduction to the field of Criminology. Among the issues to be addressed in the first part of the course are the origins of Criminology; the place and practice of law in society, the study of crime and criminal conduct and the contribution of feminism to the discipline. This will be followed by a critical examination of theories of crime and three major patterns of criminal behaviour.

**Required texts:**

Linden, R. Criminology: A Canadian Perspective. (6<sup>th</sup> edition), Nelson Education, Toronto: 2009.

\*Additional readings may be assigned throughout the course.

**Course requirements:**

The final grade for the course will be based on the following:

- 1) Group writing exercises (30%):  
September 30 – 10% October 28 – 10% November 25 – 10%
- 2) In-class Test (25%): Friday, October 7/11
- 3) In-class Test (25%): Wednesday, November 9/11
- 4) In-class test (20% of final grade): Wednesday, December 7/11

The course requirements will be based on the readings, lectures and class discussions. Students are expected to attend class and to complete the readings in advance of the lectures so that any problems, concerns or issues can be raised for discussion in class. Participation in class discussion is both welcomed and encouraged. In-class tests will be comprised of multiple choice and true/false items.

**Make-up tests and missed group exercises will not be considered unless appropriate documentation has been received.** Requests for special consideration must be made well in advance. It is the student's responsibility to notify the instructor within one week of a missed requirement or test. Neglecting to do so will result in a grade of zero for that requirement.

Requirements for the group exercises will be detailed in class.

**September 9: Introduction and overview of the course**

**September 12 - October 6:**

The first section of the course examines preliminary considerations that are critical to the field of Criminology. This includes the origins of Criminology, the place and practice of law in society and the study of crime and criminal conduct.

**Readings:** Linden, Criminology: chapters 1 - 5 inclusive.

**Friday, September 30: In-class Group exercise (10% of final grade)**

**Friday, October 7: In-class test (25% of final grade)**

**October 11 - November 8:**

The second section of the course engages a focused analysis of theories of crime beginning with an examination of the feminist critique of and contribution to new directions in criminological theory, research and practice.

**Readings:** Linden, Criminology: chapter 6 - 10 inclusive.

**November 14 - December 5:**

The third section of the course continues with the examination of theories of crime and then considers three specific patterns of criminal conduct.
