Balancing Classroom with Courtroom

You will have opportunities to study all the essentials critical to a solid legal education, and you will obtain hands-on, practical experience through our comprehensive clinical learning program later in the JD program. You will be introduced to the courtroom through the Legal Systems course and our unique Judge Shadowing program. There will be opportunities to volunteer for Pro Bono Students Canada, and starting the summer after you finish first year, you can volunteer for the University of Manitoba Community Law Centre (UMCLC).

Choose Your Path

The Faculty of Law offers JD students the opportunity to choose one of four voluntary "Concentrations" that will be noted on your transcripts upon graduation. These include:

You do not need to choose a Concentration, but if you do, you may complete only one Concentration. There is one exception: if students choose Access to Justice in French, they may also choose a second Concentration.

Implementation of Call to Action 28

The Truth and Reconciliation Commission's Call to Action 28 calls upon law schools to require all law students to take a course on Indigenous peoples and the law, including the history and legacy of residential schools. Robson Hall students all take Indigenous Legal Methodologies and Perspectives in their second year, and there are also other Indigenous law courses you can take.

Fund your Legal Education

Our tuition remains among the most affordable of Canadian law schools.

New this year are **the Faculty of Law General Bursaries**. These are funded by the [Manitoba Law Foundation](#) representing \$4.5 million in grant funds to the University of Manitoba, Faculty of Law. You can apply for these bursaries across the following categories: Truth & Reconciliation; Equity & Transformation; and Northern, Remote & Rural Access to Justice. These can cover up to full tuition and preapplications are due by July 31. <https://law.robsonhall.com/bursary-application/>.

We also have another generous bursary program for students who find themselves in **financial need**. See <https://umanitoba.ca/law/student-experience/financial-aid-awards>. Please note that students can apply for multiple sets of bursary opportunities (for example, you can apply for both the Manitoba Law Foundation and financial need bursaries).

Performance and merit-based awards are distributed to students in every course, recognizing academic excellence. The top 10 students on the Dean's Honour List entering second and third year receive a substantial scholarship and are named Pitblado Scholars.

Please note that Manitoba Student Aid is now accepting applications for student loans. We highly recommend applying early. Success in the financial need category of bursary programs is tied to student loan approval.
