#### **Access to Justice in French Concentration**

Bienvenue à la Faculté de droit de l'Université du Manitoba! We are very much looking forward to meeting you all.

### Overview of the Bilingual Law Program

The Faculty of Law offers students entering the first year of their JD program the opportunity to earn a Concentration in Access to Justice in French (A2JF), a course of study approved by the University of Manitoba Senate in 2022. Students who complete at least 26 of the 92 credits of the JD program in bilingual law courses will receive the Access to Justice in French Concentration in recognition of their efforts to acquire the linguistic competencies to provide legal services in French and English.

# **Support and Resources to Succeed**

Many of you may not have used your French in an academic context for a few years, and so you may feel unsure about participating in the A2JF Concentration. To support your participation, our partners at Université de Saint-Boniface have formulated a language assessment to provide you with a sense of your readiness for the program. The assessment also allows us to determine what supports you might need to be successful, including French tutors (at no cost), who are available year-round to help with assignments or to answer any French language questions that you may have. Information about the assessment can be found on the Faculty of Law website. We encourage you to make use of this opportunity for feedback and support that will allow you to build strong skills for your future as a bilingual lawyer.

En plus des évaluations langagières et des tuteurs, nous offrons un « Bilingual Buddy Program » dans lequel vous serez jumelés avec un étudiant bilingue de deuxième ou troisième année qui aura déjà suivi des cours de droit en français dans le passé. Your "buddy" will be able to provide guidance to you throughout your studies and answer any questions you may have regarding bilingual courses, the French language moots and internship, and more. We encourage you to take advantage of this resource as it provides a valuable opportunity for you to get acquainted with your bilingual peers in the legal profession. Last but not least, we offer a course called "Passeport du droit en français 1" that is scheduled for two to three hours each month. Passeport brings together first- and upper-year students in the A2JF Concentration to attend seminars on themes relating to the bilingual practice of law in Western Canada and the access to justice needs of francophone communities. Vous développerez progressivement votre compréhension de la langue française et vos compétences en communication tout en créant des liens avec vos collègues bilingues qui vous seront très utiles lorsque vous commencerez la pratique du droit. This course offers great networking opportunities with lawyers in the community.

While you may be apprehensive about pursuing part of your legal studies in French, please know that the two bilingual courses offered in first year (Legal Methods and Passeport) are evaluated on a pass/fail basis. This provides students the opportunity to strengthen their French abilities without worrying about their grades.

Students in the A2JF Concentration have accomplished great success academically and in moot competitions. The gold medalist for 2023 was a student who completed the requirements of the Concentration. Our bilingual students who participated in the Bastarache Moot in 2023 won second-best pair overall and second and third best oralists. Our bilingual students also placed second in the French stream of the 2023 Canadian National Negotiation Competition and won the Spirit of Negotiation Award for the French stream of the 2024 Canadian National Negotiation Competition.

## **Advantages**

There are many benefits to enrolling in the A2JF Concentration. In addition to developing your legal skills in French, students have found that participating in the A2JF Concentration has been an asset in applying for articling positions and clerkship opportunities. Students who completed courses within the A2JF Concentration have obtained articling positions with various employers, including Justice Canada and large law firms in Winnipeg, Toronto and Calgary, as well as clerkships at the Tax Court and the Federal Court of Canada.

#### **Bursaries**

The Government of Canada is funding bursaries for students whose first language is not French and who are participating in the A2JF Concentration in their first year of law studies. Nous avons d'autres bourses pour les étudiants francophones dans la Concentration en accès à la justice en français pour les aider à défrayer le coût de leurs études de droit.
